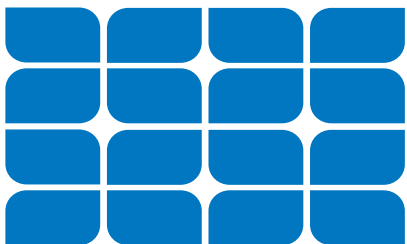

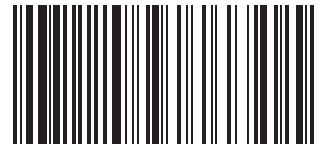

## PRECAUTIONARY MEASURES

Do not breathe the mist or spray. Keep away from heat, sparks, open flames, hot surfaces. - No Smoking. Keep container tightly closed. Ground/Bond container and receiving equipment. Use explosion-proof electrical/ventilating/lighting equipment. Use only non-sparking tools. Take precautionary measures against static discharge. Wear protective gloves, eye protection and face protection.

Store in a well-ventilated place. Keep cool. Store in original container only and keep sealed. Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program. Contact your state and local ACRC recycler or visit the ACRC web page at [www.acrecycle.org](http://www.acrecycle.org). Decontaminated containers may also be disposed of in a sanitary landfill.

**IN CASE OF FIRE:** Use alcohol-resistant foam, universal foam, water spray or water fog to extinguish.

## GENERAL INFORMATION

**Droplex® Xtra** is a multipurpose spray adjuvant designed to maximize pesticide or fertilizer performance by improving deposition, increasing canopy penetration and reducing spray drift. In addition, **Droplex® Xtra** reduces surface tension of spray droplets to improve wetting of leaf surfaces and aid pesticide absorption by the leaves and foliage. The combination of ingredients allows **Droplex® Xtra** to enhance the sticking and stopping of droplets to surfaces, thus reducing droplet bounce.

**Droplex® Xtra** does not adversely affect spray pattern like other drift control adjuvants even when using air assisted type nozzles. To maximize efficacy, use **Droplex® Xtra** in conjunction with proper: spray equipment, set-up, boom height, nozzle type, nozzle size and pressure. Good judgment, proper selection and use of spray equipment, and **Droplex® Xtra** can help professional applicators maximize pesticide performance.

## DIRECTIONS FOR USE

### — MIX WELL BEFORE USING —

Prior to use, read all directions on this label. Always check pesticide label for specific crop use and application rates. Before mixing pesticides with **Droplex® Xtra**, conduct a jar test to determine compatibility.

**Droplex® Xtra** is labeled for turf, including golf courses, lawns, sports fields, etc., ornamental, vegetation management, aquatic and pest control applications. Prior to application to ornamentals, a test spray should be done to make sure there is no plant damage. This product has not been applied to all ornamentals and therefore the safety on ornamentals cannot be guaranteed. **Droplex® Xtra** is not labeled for aquatic use in the state of Washington. In Pest control, only labeled for use outdoors.

Prior to use, read all directions on this label. Always check pesticide label for specific crop use and application rates. Before mixing pesticides with **Droplex® Xtra**, conduct a jar test to determine compatibility.

**Rate: Droplex® Xtra should be applied at a rate of 16 to 32 fl oz per acre.**

## MIXING

Add **Droplex® Xtra** after pesticides or other adjuvants are added, but prior to complete filling of the spray tank.

**Direct Injection: Droplex® Xtra** can be applied through injection systems when it is added to one of the system's chemical injection tanks. An in-line mixing chamber is recommended.

- ✓ Step 1 Add **Droplex® Xtra** to the chemical injection tank.
- ✓ Step 2 Pump the correct amount of **Droplex® Xtra** into the line.
- ✓ Step 3 Pump the proper amount of water, pesticide, and other adjuvants into the line for mixing with **Droplex® Xtra** and chemicals before going into the spray boom.

Do not mix **Droplex® Xtra** with AirTech, Atmos or Breeze in an induction system or container when all the products are undiluted. Once they are mixed in water, all the products are compatible in any mixing order.
